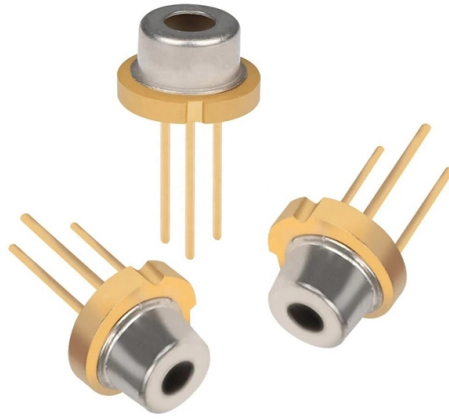

26 of Georgia's EMCs have made broadband project announcements with plans to provide approximately 339,000 homes and businesses with high-speed internet service in 108 Georgia counties through affiliates and partnership agreements. Google announced an Energy Impact Fund in partnership with Georgia Power to support programs that expand access for families to energy-saving technologies that will lead to lower electric bills and stronger local energy systems across Georgia.
